Statement Regarding the Collection, Use, and Disclosure of Personal Information by CUFA BC with Respect to the *Distinguished Academics Awards*

The Confederation of University Faculty Associations of British Columbia (CUFA BC) collects some personal information about nominees for the *Distinguished Academics Awards* to assess nominees' suitability to receive an award and in compliance with the <u>CUFA BC Privacy Policy</u>. Personal information about the nominee includes, but is not limited to, contact information, *curriculum vitae*, and letters of reference. Consenting to the collection and use of the information is required for the nomination.

Personal information collected about nominees will be used by CUFA BC as follows:

- 1) Personal information about nominees who subsequently receive a *Distinguished Academics Award* will be retained indefinitely by CUFA BC in order to provide an ongoing record of the accomplishments of the award winners.
- 2) Personal information about nominees who do not ultimately receive an award will be retained for 18 months after the date of their initial nomination so that their personal information may be used in the award adjudication subsequent to the year in which they were first nominated.
- 3) For all nominations, CUFA BC would like to publish limited personal information about each nominee's teaching, scholarly activity, contributions to the community beyond the academy, and related matters to be shared on the CUFA BC website at https://www.cufa.bc.ca/awards.
